LAWYER CHALLENGES AGF ON ALLEGED \$30,000 BRIBE TO ONNOGHEN - SUN PG.4&5

A senior lawyer, Mr. Joe Agi (SAN), has challenged the Minister of Justice and Attorney-General of the Federation (AGF), Mallam Abubakar Malami, to come up with evidence to support his claim that \$30,000 traced to the account of the suspended Chief Justice of Nigeria, Justice Walter Onnoghen, was a bribe to compromise the trial on the alleged \$3.18 billion Paris Club fruad. In a statement yesterday in Abuja, Agi alleged that the AGF and those he described as a cabal have been after him because he exposed and secured the refund of the fraudulent deduction of \$3.18 billion from local governments' account by the Federal Government as part of the Paris Club refund.

Mr Joe Agi, a Senior Advocate of Nigeria has opened up on the \$30,000 he deposited in the account of the suspended Chief Justice of Nigeria Justice Walter Onnoghen. Mr Agi in a statement explained that though he convinced the suspended CJN to open the said domiciliary account with the Standard Chartered Bank ten years ago with initial deposit of \$30,000, but insisted that the said deposit was never a bribe to the CJN.

COURT OF APPEAL FAILS TO HEAR ONNOGHEN'S SUITS - NATION PG.45, THISDAY PG.6,

THE Court of Appeal in Abuja has postponed its planned hearing of the three appeals filed by the suspended Chief Justice of Nigeria (CJN), Justice Walter Onnoghen, to February 27. It was the third time, in one month, that the court will postpone hearing in the appeals filed against the decisions of the Code of Conduct Tribunal (CCT), before which the suspended CJN is standing trial for alleged breach of code of conduct for public officers. Justice Onnoghen is, by his first appeal, challenging the jurisdiction of the CCT to hear the charge against him, being a serving judicial officer.
