#### 2021 ANNUAL REPORT ON THE IMPLEMENTATION OF THE FREEDOM OF INFORMATION (FOI) ACT 2011 SUBMITTED TO THE NATIONAL ASSEMBLY BY MR. ABUBAKAR MALAMI, *SAN* ATTORNEY GENERAL OF THE FEDERATION AND HONOURABLE MINISTER OF JUSTICE PURSUANT TO SECTION 29 OF THE FREEDOM OF INFORMATION (FOI) ACT 2011

#### 1. PREAMBLE

The Freedom of Information Act 2011(FOI) Act came into force on the 28<sup>th</sup> day of May 2011. The Act makes access to public records and information more freely available to the public while also protecting certain public records and information in the public interest. It also in some specified situations protects serving public officers from adverse consequences for disclosing official information without prior authorization.

The basic objectives of the Freedom of Information Act is to promote Accountability, Transparency, and Openness in government and to ensure that there is public participation in government, make public records and information more freely available for public access.

To ensure Public Institutions comply with the provisions of the Act, Section 29(1) requires all Public Institutions to submit to the Attorney-General of the Federation on or before February 1st of each year, a Report containing among other details, the number of FOI requests received by Public Institution; the number of determinations made by it; the number of appeals made by persons under the Act; the total amount of fees collected and the extent of manpower committed to the task of processing requests under the Act.

Further, Section 29(4) requires the Attorney-General of the Federation to notify, not later than April of the year the Ranking Minority Member of the Committee on

Government Reform Oversight of the House of Representatives and the Chairman and Ranking Minority Members of the Committee on Government Affairs and the Committee on Judiciary, Human Right and Legal Matters of the Senate, of the existence of such Reports and to make it available in hard copies as well as electronic means.

Section 29 (7) provides for the Report to be made available to the afore-stated officers of the National Assembly **"on or before April 1 of each calendar year".** 

### 2. SYNOSIS OF EFFORTS TAKEN BY THE ATTORNEY GENERAL OF THE FEDERATION AND FEDERAL MINISTRY OF JUSTICE TO ENCOURAGE GOVERNMENT OR PUBLIC INSTITUTIONS TO COMPLY WITH THE (FOI) ACT

The Federal Ministry of Justice as the focal Ministry with oversight on the implementation of the Act in the 2021 reporting year took several measures to ensure and encourage Public Institutions to compliance with the provisions of the FOI Act. Among the numerous efforts includes;

- (i) The celebration of the tenth year of the implementation of the FOI Act, 2011 in Nigeria on 13<sup>th</sup> July, 2021 as part of efforts towards appraising the implementation efforts of all Public Institutions to which the Act applies..
- (ii) In view of the cardinal role of Proactive Disclosure in the implementation process, a database for Freedom of Information Desk Officers in Public Institutions was developed and populated to enhance their understanding of the application process. It is noteworthy to mention that an increasing number of Public Institutions have deployed FOI portals on their website thereby becoming sensitive to the Proactive Disclosure requirements under the FOI Act.
- (iii) The Ministry's FOI Unit maintained its quarterly interface and conversation with FOI Desk Officers across Public Institutions and offers advice, opinion and counseling to Public Institutions in complex FOI related issues.
- (iv) The FOI Unit of the Ministry of Justice Facilitated FOI workshops and seminars organized for Public Institutions by Non- Government Organizations

and Civil Society Organizations. The Unit was involved in the Capacity Building programme organized by Media Initiative against Injustice, Violence and Corruption (MIIVOC) for the development and deployment of the Proactive Disclosure Protocol in August 2021. The Unit also facilitated the Capacity Strengthening programme organized by Ceelaw Investment Limited for members of the FOI Committee of the Central Bank of Nigeria and the Office of the Accountant General of the Federation. The Unit participated at the FOI Training for staff of National Agency for the Control of Aids, (NACA) organized by Justice Reform and Development Initiatives and Members of the FOI Committee of the Federal Ministry of Labor and Employment, Federal Ministry of Works and Housing & the National Directorate of Employment.

- (v) More emphasizes was devoted to Records keeping and Records Management as the prerequisite for effective compliance by Public Institutions.
- (vi) In line with Section 13 of the FOI Act, the Ministry has always reminded Public Institutions of the importance of capacity building and ensure the provision of appropriate training for its officials on the public right to access information or records held by them.

The foregoing underscores the fact the Ministry has engendered a synergy and collaboration leading to a tremendous improvement in the applicability and usage of the Act by the Public. A sustainable effort on the part of the Public Institutions to meet the increasing demand of the general Public and meeting their statutory obligations to the Office of the Attorney General of the Federation are the expectations in the years ahead.

# 3. NOTABLE FACTOR HINDERING THE EFFECTIVE AND SUSTAINABLE IMPLEMENTATION OF THE FOI ACT

As was noted earlier, Nigeria marked ten (10) years of the implementation of the FOI Act, 2011 and as is the case with all novel laws, there are bound to be challenges of implementation. It should be noted that the FOI Act was not passed until after a period of 17 years from its first reading in the National Assembly. Unfortunately during the period of advocacy for the passage of the law, very little was done to gain public support and sensitize all operators of the Act on their expected roles in its implementation.

There is still the perennial challenge of trying to shrug off a culture of secrecy and embrace the values of transparency and openness embedded in the Act by public officials. Each tier must complement the other and aim towards effective and sustainable implementation of the Act. It is therefore a matter of concern that in spite of reminders on submission of Annual Implementation Report to Attorney General of the Federation as stipulated in the FOI Act, the compliance index shows that a sizeable number of Public Institutions has not adhere to their reporting obligations since the Act was enacted.

In the year under review, some of the challenges encountered are highlighted below:

- a) Lack of effective record keeping and systematic means of record management in a manner that facilitates public access.
- b) Inadequate or non-financial provisions to fund FOI Act activities. There is general lack of funding for FOI activities in some Public Institutions.
- c) There is general apathy amongst those that should operate the Act. This is worsened by a high level of ignorance about the provisions of the Act and the nature of obligations expected of Public Institutions. There is therefore need for intense and continuous sensitization of Government officials.

- d) Public Institutions invariably respond to requests well beyond the seven (7) days required by the Act primarily because they lack necessary structures to respond due to ignorance of timelines stipulated in the Act.
- e) There is also the challenge of bureaucracy and bottlenecks in most Public Institutions that hinders the effective compliance of the Act.
- f) The FOI Act does not provide for sanctions for failure to submit Annual Implementation Report by Public Institutions to the Attorney General of the Federation. For now the Ministry is using "naming and shaming" pending when appropriate punitive administrative measures would be put in place to punish defaulting Institutions. The Ministry is also employing constant reminders to Public Institutions on mandatory compliance with provisions of the Act.
- g) Refusal of high percentage of Public Institutions to set up FOI Units and to designate Desk Officers in line with Chapter 6.16.1 of the Guidelines on the implementation of the FOI Act 2011.
- h) Reluctance of Public Institutions to develop FOI online portal to proactively publish their activities, operations and businesses as required by the Act to enable easy public access.
- i) Inadequate Training of Public Institutions officials on the Act.
- j) Gross under -utilization of the Act by the Public.
- k) The Unit rendered timely legal advice to quite a number of Public Institutions towards fulfilling the HAGF mandate of ensuring compliance.
